



**INVITATION FOR BIDS
FOR ESTABLISHMENT OF CAFETERIA ON RENTAL BASIS AT MMC MARDAN**

Medical Teaching Institution (MTI) Mardan, Khyber Pakhtunkhwa was established under Khyber Pakhtunkhwa Medical Teaching Institutions Reforms Act, 2015 to improve performance, enhance effectiveness, efficiency and responsiveness for the provision of quality healthcare services to the people of the Khyber Pakhtunkhwa.

Quality food in a cafeteria is characterized by its nutritional value, taste, and overall appeal to consumers. It involves using fresh, high-quality ingredients, implementing proper food safety and hygiene practices, and offering a variety of appealing options. If the quality of food is compromised, it can have serious repercussions. A wrong diet can further deteriorate the patient's condition. Rotten, infected or poisonous food can lead to food poisoning and even mortality.

To cater for all these serious repercussions, the Hospital Director invites sealed bids for establishment of a well-versed **CAFETERIA FOR PROVISION OF QUALITY FOOD IN THE PREMISES OF THE HOSPITAL** for Patients, Staff and Visitors by following local & international standards in light of rule 50-D of KP-PPRA Rules 2014 from the eligible individuals / well established food chains under **Single Stage Two Envelope** procedures. The bidder must be registered with the Income / Sales tax and KP-Revenue Authority (KPRA), reflected in the Active Taxpayer List (ATL) of the Federal Board of Revenue.

PRE-BID MEETING with the interested bidders will be held on 24-10-2025 (Friday) at 10:00 hrs. in the conference room of administration block.

Bid Solicitation Documents containing detailed descriptions including evaluation criteria and other terms & conditions, may be obtained from the office of the undersigned between 09:00-15:00 hrs on any working day (Monday to Friday) by depositing a sum of Rs.3000/- as "Non-Refundable" from the date of publication of this advertisement in the newspaper till last date for submission of bids. The advertisement may also be downloaded from www.kppra.gov.pk and www.mmckp.gov.pk websites.

The bidders are required to submit bid security (in original) of an amounting to Rs. 2,500,000/- (Two Million Five Hundred Thousand Only) in the form of Call Deposit Receipt (CDR), Demand Draft (DD), Pay Order or banker's cheque in the name of "Hospital Director MMC Mardan". An affidavit is mandatory in the technical bid that bid security is placed in the financial bid.

Each envelope shall contain a separate Technical and Financial bid clearly marked in bold & legible letters. The firms shall provide their complete information along with their postal as well as valid email address and phone number/s on each of the respective envelopes.

Bids complete in all respect should reach the undersigned by **11:00 AM on 03.11.2025 (Monday)**. Only Technical Bids shall be opened at **11:30 AM** on the same day in the conference room of the institution in the presence of the procurement committee and the bidders / representatives, who may choose to attend. The Competent Authority, on recommendation of the Asset Disposal Committee, shall award the contract in light of Rule 50-D(7) of KP-PPRA Rules 2014 to the bidder with highest quoted bid.

Competent Authority reserves the right to reject any or all the bids as per provisions contained in Rule 47 of KPPRA Rules 2014.
